"Ontario's Not-for-Profit Corporations Act, 2010 will not take effect for at least two years. The government has promised to give at least 24 months notice to the nonprofit sector before the ONCA takes effect.

Most organizations should not make changes to comply with the ONCA yet, as possible amendments, if passed will change some details."
